## **REGISTER OF COMMONERS**

### **DARTMOOR COMMONS ACT 1985**

**The Dartmoor Commons Act requires the Commoners' Council to maintain a Register of Commoners and other graziers of the commons. The Register is also the list of electors to the Commoners' Council.**

**It is the duty of every Commoner, who currently grazes, to register his rights and facts relating to grazing. It is the right of every Commoner who wishes to vote, to register himself. Graziers who are not commoners, but use the commons by virtue of ownership, tenancy or licence, are also required to register by the Act. (It is the legal duty of every grazier to provide all the facts required for registration and to notify the Secretary of the Dartmoor Commoners' Council of any changes to these facts as they occur so that the registration can be amended accordingly.)**

**If you do not know the Common Land Unit Number or the Entry Number in the 1965 Act Register in County Hall it can be supplied later. You must, however, be precise about the numbers of stock and the name(s) of the commons grazed.**

**Where rights are held jointly or by a Company, then a single elector (one of the partners, trustees or directors) must be nominated in the space provided at 1 over leaf.**

**PLEASE COMPLETE A SEPARATE FORM FOR EACH HOLDING OR ADDRESS FROM WHICH SEPARATE GRAZING RIGHTS ARE EXERCISED WITH DIFFERENT FLOCKS AND/OR HERDS, OR INDIVIDUAL ANIMALS, OR TO WHICH NON-GRAZING RIGHTS ATTACH.**
